- 1) CUSTOMER will pay the full amounts in accordance with the terms stated on each invoice(s).
- 2) If payment in full is not received by Western States Metals, Inc. on or before the invoice due date, the account shall be subject to a 1.5 % service charge per month (18% pen annum), or the maximum allowable by law, from the due date until the payment is paid in full.
- 3) In the event the account is placed in the hands of a licensed collector or an attorney for collection, or suit is instituted, CUSTOMER agrees to pay, in addition to the delinquent amount, service charges, actual court costs, collector's and/or attorney's fees.
- 4) Venue, should a lawsuit become necessary, shall be at the sole discretion of Western States Metals, Inc.
- 5) All claims for shortage, damage, or defective materials are waived unless made in writing within five (5) days of shipment.
- 6) Western States Metals, Inc. shall not be responsible for special, consequential, incidental and/or punitive damages as a result of shortage, damaged, or defective material. The CUSTOMER'S sole remedy shall be the replacement of the material or refund of the purchase price.
- 7) All returns of material may be subject to a restocking charge of 10% of the invoice amount.
- 8) Non-stock sizes and processed material, when furnished correctly, can not be returned for credit.
